The Building Tune-Up Program is designed to optimize the energy performance of your facility's building automation system (BAS) by identifying low-cost solutions that will make your building more energy and cost-efficient.

Eligibility

Indiana small and medium size businesses that have CenterPoint Energy electric service, with <500 kW peak demand and a facility ≤150,000 square feet, that have not opted out of participating in our energy efficiency programs, are eligible.

Businesses with >500 kW may still apply, but may be subject to increased customer spending commitments. **Facilities must** have a centralized BAS to be considered. Terms and conditions apply.

A no-cost expert review of your building's BAS may help you:

- Save up to 10-15% annually on your gas and electric services for installed energy-saving improvements
- Receive an average payback of less than 1.5 years on improvement projects
- Improve and maintain building occupant comfort

Program incentive

A program energy advisor conducts a building tune-up study fully-funded by the CenterPoint Energy program. Participants receive a report detailing no/low cost savings opportunities at your facility. Additionally, a cash incentive is offered covering up to 100% of implementation costs, with a maximum payout of \$5,000. In return for the no-cost study, customers must select at least \$5,000 worth of recommended savings opportunities to implement. See the Building Tune-Up Program application for more details.

How the program works

- 1. Complete and submit the building tune-up application
- 2. Receive pre-approval for a building study
 - Acceptance into the program may be dependent on the savings potential of the project.
 - Approved participants are required to meet the minimum spending commitment of \$5,000.

3. Schedule a time for your building study

A program advisor will spend a day at your facility to perform a no-cost energy assessment.

4. Select and install recommended building tuneup improvements

5. Measurement and verification

- The program advisor will confirm all improvements were implemented as expected.
- Once verified, you will receive a report summarizing your savings and the incentive will be paid.
